

**PROCEEDING OF THE DISTRICT REVENUE OFFICERS MEETING HELD ON
11.02.2011 AT COLLECTORS CONFERENCE HALL, CHATRAPUR**



The meeting was presided over by the Collector (I/C)-cum-A.D.M.(Revenue), Ganjam and attended by the Sub-Collector, Chatrapur, Berhampur & Bhanjanagar and all Tahasildars, Deputy Director, Agriculture, Berhampur, Mining Officer, Ganjam Circle, Berhampur and District Sub-Registrar Chatrapur. At the beginning of the meeting A.D.M. welcomed all the participants to the meeting and the following discussion have been made in the meeting.

CROP LOSS & PAYMENT OF EX-GRATIA

Threadbar discussion has been made on the assessment of crop loss, preparation of farmers list and payment of ex-gratia to the beneficiaries. All the Tahasildars were instructed to submit the list of farmers by approving the village committee for kind approval of Collector. At the 1st instance all the Tahasildars were directed to submit the list of one R.I. Circle by 25th of February, 2011 after observing all formalities for approval of Collector so that disbursement can be started from 1st March, 2011. It was also directed that till approval of the list by the Collector, no such payment should be made.

The following decisions have taken to start the payment at the earliest.

1. List should be prepared and approved as per new format.
2. The payment shall be made to the beneficiaries through banks through electronic fund transfer system/ Real Time Gross Settlement.
3. All the Tahasildar should give their account number for this purpose.
4. Deputy Director, Agriculture to depute their staff to Tahasil to assist Tahasil staffs for rechecking of the assessment already made before approval of the village committee.

CENSUS :-

The following progress was reported by the Tahasildars. It is reported by them that Census Rally has been made in all Tahasil area and payment has also been made to the enumerator except Tahasildar, Bellaguntha. It is reported by the Tahasildar, Bhanjanagar that financial power has not been accorded in favour of him for which payment could not be paid. Sub-Collector, Bhanjanagar is instructed to submit the proposal for delegation of financial power.

Settlement of Sairat Sources :-

Collector(I/C) has expressed his displeasure on the performance on settlement of sairat sources during the year 2011-2012. All the Tahasildars have reported that the approval in respect of sources having upset price more than Rs.50,000/- (Rupees Fifty Thousand) have been obtained from the concerned Sub-Collectors. It is also reported by the Tahasildars that by end of March, 2011, all the sources shall be settled.

Proposal has been placed by the Sub-Collectors to move Government in Revenue & D.M. Department for extension of the upset price limit from Rs.50,000/- to Rs.1,00,000/- as most of the upset price of the sources are more than Rs.50,000/-.

The instructions of the Govt. in Revenue & D.M. Department vide No. 4123 dated 25.01.2011 has been discussed and the Tahasildars were directed to implement the instruction of the Govt. in letter & Spirit. Sub-Collectors were instructed to ensure on the implementation of the Govt. instructions.

PROTECTION OF GOVT. LAND :-

All the Tahasildars were directed to report the progress on Protection of Govt. land in fortnightly basis. The Tahasildar, Berhampur to report the same on weekly basis as desired by Collector.

GRAMAKANTHA:

The progress on the settlement of Gramakantha land was reviewed. The progress on disposal of cases is not up to mark. All the Tahasildars were directed to gear up their field functionaries on collection of application form as well as settlement of gramakantha land within the stipulated period. Further, it is decided in the meeting to move Government for extension of time for another six months for collecting application as the time in force shall be expired on 17th February, 2011.

Detection of Cases under 2/56 in schedule Area

It is pointed by the A.D.M that the Sub Collector, Bhanjanagar was asked in the last revenue meeting to initiate 349 cases of illegal transfer of land in the scheduled area of Sorada Tahasil on the report of Sub Registrar Sorada. Only 33 cases has been instituted by the Sub Collector so far . He has expressed his displeasure and again instructed Sub Collector Bhanjanagar to take immediate steps for initiation of case on these reports immediately.

Detection of cases u/s 23 & 23 A of O.L.R Act

It is pointed by the ADM that the highest pending is 232 in Bhananagar Sub Division followed by 220 in Berhampur Sub Division and 31 in Chatrapur Sub Division. Against the pendency the Sub Collector, Bhanjanagar and Chatrapur have not disposed of any case during the month under review, ADM hass expressed his displeasure on the poor performance and instructed all the Sub Collectors to expedite the disposal during the coming months.

DISPOSAL OF REVENUE CASES.

A.D.M. Revenue reviewed the institution and disposal of various type of Revenue cases by the Tahasildars during the month of January ,2011 in the Meeting. He has instructed all the Tahasildars to take sincere efforts to reduce the pendency of Mutation and encroachment cases during the coming months

Alienation case

A.D.M has reviewed the Tahasilwise pending of alienation/leases cases in the district. He has instructed all the Tahasildars, to submit all proposals pending with them immediately.
